Food Pantry:

Providing food to our clients on an emergency and on-going basis. Our clients are referred from, other agencies, local churches, self referrals, or our outreach programs. Individualized pantries are put together and issued to the client, along with information about other programs and agencies that may be able to assist them.

A typical pantry consists of 68 staple items and 9 bulk items.

1907 people were provided multiple pantries in 2013.

148 dinners were provided for Thanksgiving.

140 food baskets were provided for the elderly during the year

Pantries are packed by 1 employee and 1 volunteer.

Thrift Store:

Provide clothing to our clients free of charge or at a nominal cost depending on the ability of the client to pay for the items. Additionally, coats, hats and gloves are provided free to those in need of these winter items each fall.

Provide a location for local residents to drop off used and discarded clothing or other small items,

Free clothing to 43 people who say they do not have money, most from being released from jail or prison.

A total of 159 families, 455 children, 298 adults were provided gifts and clothing for Christmas.

110 Children we given new coats, hats and gloves, and 40 children were given snow pants in 2013.

Backpack Buddies:

A team of 20 volunteers pack a small lunch bag with 5 nutritious snacks that get sent home inside the child's backpack each weekend of the school year (October to mid-May). Children must qualify for free or reduced lunch and have a parent sign a permission form. Confidentiality is kept because names of all participants is left in the hands of school officials.

The Board of Directors at Feed and Clothe My People has made a commitment not to leave out other children at home between the ages of 2-8 years. Therefore, some children are taking home more than one bag each week. Health information slips are attached to the outside of the bag.

The program served 304 children in 2013 for a total 8,732 Bags packed.
